For the purpose of inducing the extension of credit by Kamco to the applicant identified able and its successors, the undersigned warrants and represents that the information provided is true and correct and, the undersigned jointly and severally, unconditionally, and irrevocably personally guarantee the full and prompt payment of all indebtedness of the applicant to Kamco including finances charges in the amount of 1 1/2% per month, plus collection costs and expenses incurred by Kamco including attorney's fees of one-third of the total amount that is due. The undersigned agree that in the event of default that Kamco will be entitled to payment from the undersigned, and their heirs, estates, and successors, without prior demand on the applicant and without proceedings against the applicant first.
